Klinger that Council unanimously approves the advertisement of the Legal Notice of the Adoption of Ordinance required by LGUDA authorizing the Borough to borrow the sum of \$350,000.00 for completion of the Cross Street Culvert Replacement Project and authorizes Solicitor Zimmerman to attend to the advertisement of Council's actual adoption the necessary ordinance at its March 6, 2023 public meeting. Motion Carried.

Mifflintown Borough Council at its meeting of March 6, 2023 on Motion of Councilperson Turns and second of Councilperson Nearhood Mifflintown Borough Council unanimously authorizes President Samuel Klinger, Vice President Richard Zimmerman and Secretary Nancy Zimmerman to execute on behalf of Mifflintown Borough the completed and finalized LGUDA packet once the required Second advertisement of Ordinance Adoption has been completed. Motion Carried.

Mifflintown Borough Council at its meeting of March 6, 2023 on Motion of Councilperson S. Klinger and second of Councilperson Turns Mifflintown Borough Council unanimously authorizes Secretary Nancy Zimmerman to issue a check in the amount of \$60.94 payable to the Commonwealth of Pennsylvania representing the filing fee for the completed LGUDA packet to DCED and further authorizes Solicitor Randall Zimmerman to then submit the completed LGUDA packet on behalf of Mifflintown Borough to the Department of Community

and Economic Development seeking their approval of Mifflintown Borough's proposed borrowing of \$350,000.00 from Pennian Bank. Motion Carried.

Mifflintown Borough Council at its meeting of March 6, 2023 on Motion of Councilperson Nearhood and second of Councilperson Turns Mifflintown Borough Council unanimously authorizes President Samuel Klinger, and Secretary Nancy Zimmerman to execute on behalf of Mifflintown Borough the REVISED BORROW AND/OR WASTE AGREMENT between Mifflintown Borough and Glenn O. Hawbaker, Inc. and directs Solicitor Randall Zimmerman to submit the same to Glenn O. Hawbaker, Inc. for signature and implementation. Motion Carried.

MAINTENANCE: Mark reported that the Christmas decorations were down and that Donny Goshorn was to give them a quote of the receptacles, but has not yet. He cleaned the bridge up on Front Street and Sam helped. He worked in the garage, painted the door to the office and bathroom. He fixed a sign by the baseball field. He fixed the door on the pavilion, fixed and painted it. He got a new flag. All meters have been calibrated. The light diffusers are all up. The pavilion roof has been fixed. Mark stated that he needs to get a hold of Wendy of CCDS regarding Spring Clean up. He also reported that the last week of April the water will be turned at the park.

METERS: Zina reported that she collected \$845.47 in meter money, \$755 in ticket money, for a total of \$1600.47. She issued 59 tickets. He reported that five parking permits were renewed; one new one issued, and two more run out in March and April. Council directed the secretary to send the County a letter asking that they pay their parking money monthly.

MUNICIPAL REPORTS: Mayor McGinnis reported on the Hometown Heroes Program. There is an application they hand out to the people. She showed samples of the flags; they supply the hangers. There are three sizes. The banner and the bracket run around \$205 usually. People pay for this and submit a digital photo, and we should give them a deadline. There is a minimum of 10. They want 50% of the banner cost up front. The fee should be brought in with the application. On motion of S. Klinger, second by R. Zimmerman, council agreed to go forward with this project. Motion Carried.

Mike Smith approached her about tearing down a garage between the Singer property and the post office building. He will pay the \$50 and get a demolition permit.

ANY OTHER BUSINESS: Councilman Brian Baker suggested changing the traffic pattern on Bridge Street to one-way toward the pedestrian bridge and making angle parking.

Vice-President R. Zimmerman received a concern from Diane Marshall about kids on the bridge railing by the Legion. He told her to contact PennDot.

On motion of S. Klinger, second by Baker, the secretary is to pay the bills for the month of March. Motion Carried.
