Mifflintown Borough November 4, 2024

The borough council of Mifflintown met on this date in the municipal building at 100 Cross Street, Mifflintown PA. The meeting was called to order by President Klinger at 7:00p. The following were in attendance: Samuel Klinger, Richard Zimmerman Jr, Mark Turns Jr, Mayor McGinnis, Karen Haas, Brian Baker, Mark Aurand, maintenance, Zina Klinger, meters, and Robin Saner, Sec/Treasurer.

Zina wrote 60 tickets for the total of \$571.70 and deposited \$1261.67 from the meters. Total received, \$1833.37. Zina also reminded the group of the Christmas Tree Lighting on Saturday, December 14, 2024 at 5:30p. Next up was Mark. He reported all the various things he's been working on: fixed road signs, changed the time on the school signs, fixed drains and cold patched behind Joe Benner's old building and downtown on Lemon St, painted the ramp outside of the borough building with grit in it to make it safer when it's icy out, cleaned up the pavilion area at the playground from the Lions using it at their BBQ (they left a mess) cleaned out the BBQ pit, cleaned the access road by the library and many other various fixes in the borough. The Christmas lights are scheduled to be put up by Donnie Goshorn on November 15th. The council decided not to approve replacing the receptacles on the poles beforehand.

The minutes from October's meeting were approved with a motion 1^{st} by Zimmerman Jr and 2^{nd} by Baker. The treasurer's report was also approved. A motion made 1^{st} by Zimmerman Jr and 2^{nd} by Turns Jr.

The council approved to pay the PIRMA insurance invoice of \$13,070, motion made by Turns Jr 1st and 2nd by Haas. The council also approved the invoice of \$7200 from Glenn O. Hawbaker to be paid, 1st by Klinger and 2nd by Turns Jr. And lastly the council approved the purchase of a new printer/copier for the borough office for \$235. Motion by Baker 1st followed by Haas 2nd. Saner will go to High Tech hobbies to get it.

Mayor McGinnis performed two wedding ceremonies and received \$80. She attended a table-top exercise. It was a simulation of 2 gas trucks colliding at the square during school hours and the safety measures taken within the whole county to secure the safety of the public. She attended Trunk or Treat at the Children & Youth office. The mayor told council the gentleman who did the ice sculptures for New Year's Eve retired so there will not be any sculptures this year; however, she is working on decorated snowmen to be placed around.

There is nothing to report in unfinished business. In new business the council reviewed the 2025 budget which will be available to the public up until the next council meeting in December which has moved to December 9th at 7:00p. Saner will advertise both in the local papers. The council also approved the purchase of 3 gift cards at a cost of \$75 (3 x 25) to give to their employees for Thanksgiving. Motion by Zimmerman Jr 1st and 2nd by Baker.

Council approved for the November bills to be paid 1^{st} by Turns Jr and 2^{nd} by Zimmerman Jr. And adjournment was at 8:00p with a motion 1^{st} by Baker and 2^{nd} by Haas.
