

Mifflintown Borough
January 6, 2024

The borough council of Mifflintown met on this date in the municipal building at 100 Cross Street, Mifflintown PA. The meeting was called to order by President Samuel Klinger at 7:00p. The following were in attendance; Richard Zimmerman Jr, Vice President; Mark Turns Jr, Brian Baker, Karen Haas, Mark Aurand, maintenance; Zina Klinger, meters; and Robin Saner, Sec/Treasurer. George Gray was also in attendance. He was here to speak on behalf of his granddaughter, Willow Campbell on a matter which turned out be an issue between landlord and tenant.

Zina, meters reported she wrote out 55 tickets for the amount of \$670. Meter money collected was \$895.78 for a total of \$1515.78 for the month of December. Speaking next was Mark, maintenance. He reported to council that the Christmas lights and decorations were taken down and the swags removed from the meters. The basketball hoop was painted and put back together; he fixed the roof over the BBQ pit at the playground; installed more tread on the ramp out front; had the truck and skid loader serviced; he made repairs at the borough building; spread stones on Cross Street. Fermanagh Township knocked down two of our street signs when they were plowing and said they would replace them. Kyle Kint coming on Mt Luther King Day to take down a tree by the library. After that there will still be two more trees to do.

Minutes from the previous meeting were approved with a 1st from Haas and a 2nd from Baker. The treasurer's report was also approved with a 1st from Zimmerman Jr and 2nd by Turns Jr. In correspondence there was one exoneration to be approved by the council and it did with Baker making the 1st motion and Klinger making the 2nd. Council instructed Sec Saner to deduct the spillage fine from Cocolamus Creek Disposal on the next contract payment since they haven't paid it so far.

Mayor McGinnis was absent from the meeting. Zimmerman Jr reported on her behalf the NYE celebration was a success. Good attendance and everyone had a good time. The 5k race went well also. In old business council will need to make another Police Pension Fund deposit in January for the amount of \$6777. Saner will take care of that with JVB later in the month. New business President Klinger wanted approval to plug into the borough's electricity at one of the poles down by the bridge next year at Christmas for the lights on the Christmas tree. He will run a wire at his own expense. Baker made a motion 1st with Turns Jr 2nd.

Secretary Saner requested February's meeting be moved to the following week or Monday, Feb 10, 2025. Council agreed. Saner will advertise the change in the paper and have put on the website. Council voted on the bills to be paid with a motion made by Baker 1st and Haas 2nd.


The meeting was adjourned at 7:00p on a motion made 1st by Baker and 2nd by Turns Jr.
